BSTI received BAB accreditation certificate

Bangladesh Standards and Testing Institution (BSTI), received accreditation certificate from the Bangladesh Accreditation Board (BAB) in a ceremony held in Dhaka on 24 January 2018. BSTI achieved accreditation in biological, chemical and mechanical laboratory testing for following international standards and infrastructure. Industries Minister Mr. Amir Hossain Amu M.P. officially handed over the certificate to the BSTI Director General.

BAB Director General Mr. Md. Monwarul Islam presided over the function where Additional Secretary of Industries Ministry Mr. Enamul General of BSTI Mr. Sardar Abul Kalam spoke at the function while high officials of the Ministry of Industries and the Chiefs of the different Corporation and Department under the Ministry were present.

Speaking on the occasion, the Industries Minister said, the main responsibility of the BSTI is to strengthen the country's economic base by improving the standard and quality of the products and services. Although BSTI is working under the supervision of the Ministry of Industries, it has huge responsibilities and public importance that needs to be addressed.

BSTI has made a significant contribution to the country's exports of more than 34 billion US dollars. To increase the export volume, the country will have to produce more quality products. To this end, he advised to strengthen BSTI's quality assessment program at per international standards.

Mr. Amu said that shrimp import from Bangladesh to the European Union market was ceased in the past due to malpractice of the exporters by mixing iron in shrimp. Such untoward incidents have taken place due to manipulation of testing certificate.

He warns the officials and employees of BSTI about the misuse of currently acquired accreditation certificate. He also instructed BAB officials to continue the abrupt visits to the accredited laboratories in order to maintain the improved quality and standards.

He also mentioned that at present, quality of food and beverage, cement, steel, iron and textile products are tested in accredited BSTI laboratories. With this achievement, the acceptance of the BSTI testing certificates will be increased in local, regional and international levels.

"BSTI testing certificate will be accepted globally from now on following this recognition which will result in creating global market for our products and services," said Amu. "At the same time, BSTI will continue qualitative testing and research work for health protection of the country's people", he added.

What's New in Revised ISO/IEC 17011: 2017

Across the world accreditation body operates its accreditation activities in line with international standard ISO/IEC 17011. This standard specifies requirements for the competence, consistent operation and impartiality of accreditation bodies assessing and accrediting conformity assessment bodies. The first edition of this standard was published in 2004 and the second edition was in November 2017.

In the revised standard 15 new definitions introduced, 3 definitions were deleted and one definition was modified. Though majority of requirements of previous edition have been included in the revised standard, there are some mandatory changes:

- Alignment with mandatory structure of CASCO standards
- · Introduction of mandatory language for:
- Impartiality, Confidentiality, Handling complaints and appeals, Management system requirements, Provision of options for compliance with management system requirements, Option A vs. Option B
- Broader scope → standard applicable to accreditation of a wider range of conformity assessment activities
- Greater flexibility for ABs to establish 'risk based' surveillance of CABs
- Recognition of the wide range of conformity assessment activities
- Traditional assessment methods may not be the only mechanism

International Laboratory Accreditation Cooperation (ILAC) and International Accreditation Forum (IAF) jointly have already defined 3 year transition period from the date of publishing the revised verswion. All member accreditation bodies need to complete transition to revised ISO/IEC 17011:2017 by November 2020 and all evaluations (initial, re-evaluations, extensions and follow-up evaluations) from 1 July 2018 will be carried out using the revised standard.

What's New in Revised ISO/IEC 17025:2017

All over the world the testing and calibration laboratories operates activities as per International Standard ISO/IEC 17025. This document is applicable to all organizations performing laboratory activities, regardless of the number of personnel. Laboratory customers, regulatory authorities, organizations and schemes using peer-assessment, accreditation bodies, and others use this document in confirming or recognizing the competence of laboratories.

Earlier he standards was published as guide 25 in 1995. The 1st edition of ISO/IEC 17025 published in 1999. The 2nd edition published in 2005 and the 3rd edition was in December 2017. Major Changes in the newest version included eight clauses whereas earlier version had five and 9 new definitions were introduced or modified.

Most of the clauses of ISO/IEC 17025:2005 is kept continue in the current version. The main changes compared to the previous edition are as follows: Alignment with mandatory structure of CASCO standards, introduction of mandatory clauses for:

 Impartiality, Confidentiality, Provision of options for compliance with management system requirements- Option A Vs Option B, the risk-based thinking applied.

There is greater flexibility than in the previous edition in the requirements for processes, procedures, documented information and organizational responsibilities.

International Laboratory Accreditation Cooperation (ILAC) and Asia Pacific Laboratory Accreditation Cooperation (APLAC) have already defined three years transition period from the date of publishing the standard.

BAB will establish a plan will be communicated to the existing and potential clients, regulatory and statutory bodies and other interested parties very soon for executing the transition period of ISO/IEC 17025:2017.
